Mr. Parrish stated that due to the November 28, 2019 meeting date being on Thanksgiving and the December 26, 2019 meeting date falling one day after the Holiday, a recommendation is being made to change the November 28, 2019 meeting date to November 21, 2019 and the December 26, 2019 meeting date to December 19, 2019 for the Technical Advisory Committee meeting.

Mr. Anderson moved to follow staff recommendation to approve the rescheduled meeting dates.

Mr. Parrish stated that the report is in the agenda and the most current sales tax handout was distributed to the committee. The sales tax is showing that \$420,000 more than estimated was received, which equals approximately 4 ½ percent. The numbers indicate that District is about 2.6 percent above estimate with only being two months into 2019.

Staff recommends acceptance of the financial reports.

Mr. Littrell moved to follow staff recommendation.

6. Action to adopt amendments to the RFCD Policies and Procedures Manual – 2019 annual review/update (For possible action)

Mr. Parrish stated the following changes are being proposed:

- Section I Organization Changing the language to state that a member's primary residence must be in the jurisdiction they are representing.
- Section I.G.1.c Increases the General Manager's signature authority from \$50,000 to \$100,000 without Board approval.
- Section IV Project Administration
 - o Section IV.C.6 Increases the General Manager's signature authority on Change Orders from \$50,000 to \$100.000.
- Section V Payment for Projects funded by Interlocal Contracts -
- Section V.A.A.a.1-6 Clarifies what costs are being paid by the District and what is eligible for reimbursement.
- Section V.D.A.b.2-4- Redefines the waiver requirement for the cap on engineering percentage costs for both design interlocal contracts and construction interlocal contracts. Proposing to increase the cap from seventeen (17%) percent to twenty (20%) percent, equally split between the two. If the cap is exceeded a waiver will be required.
- Section VI Interlocal Contracts
 - Section V1.B Entity labor cost was added with no additional changes.
 - Section V1.C.3.d A written request must be made to the District and approved by the Board to change the cost of the phases of the project by reallocation of funds. Entity approval no longer required.
 - o Section V1.C.4.j Clarifying construction and design phases.
 - o Section V1.E.4.a Clarifying what eligible to be reimbursed.
 - Section IX Consultants Increases the signature authority for the General Manager from \$50,000 to \$100,000 for contracts.







SECTION I - SCOPE OF THE PROJECT

This INTERLOCAL CONTRACT applies to design engineering and other costs associated with the Pittman – Sunset, Galleria to Foster project. The basic improvements shall consist of flood water facilities including reinforced concrete boxes, channel structures, channel access and other

Construction Program; and

appurtenances as may be necessary to control floodwaters. The improvements shall be funded through DISTRICT funds as herein described. This project is further identified and shown on the attached Exhibit "A".

SECTION II - PROJECT COSTS

The DISTRICT agrees to fund project costs within the limits specified below:

- 1. The engineering and design shall not exceed \$465,788.00.
- 2. The design engineering entity labor costs shall not exceed \$50,000.00.
- 3. Environmental costs shall not exceed \$50,000.00.
- 4. Survey/Right-of-way costs shall not exceed \$40,000.00.
- 5. The total cost of this Contract shall not exceed \$605,788.00 which includes all the items described in the paragraphs above.
- 6. A written request must be made to the DISTRICT and approved by the Board to reallocate funds between phases of the project. No other approval by the Lead Entity is required.
- 7. A written request must be made to the DISTRICT and a Supplemental Interlocal Contract approved by the Board to increase the total cost of the contract noted above prior to payment of any additional funds.

SECTION III - GENERAL

- The Clark County Regional Flood Control District shall be shown on the title sheet of both the plans and the specifications as the funding agency.
- The CITY will comply with the Local Purchasing Act, Chapter 332 and Public Works
 Projects, Chapter 338, of the Nevada Revised Statutes.


- The CITY, its employees, and representatives shall at all times comply with all applicable laws, ordinances, statutes, rules, and regulations in effect at the time work is performed on the PROJECT.
- 4. The CITY will require appropriate financial security for the construction of the PROJECT.
- 5. The CITY shall provide all impacted entities and the DISTRICT with the opportunity to provide the CITY with input relative to the following processes: scope of services development; consultant selection; design, construction and maintenance review; and monitoring of the effectiveness and impacts of facilities on flood flows.
- 6. Applicable portions of the current editions of the Policies and Procedures, the Hydrologic Criteria and Drainage Design Manual, and Uniform Regulations for the Control of Drainage adopted by the DISTRICT will apply in developing this PROJECT unless specifically superseded by this CONTRACT.
- 7. Purchases of right-of-way in excess of that actually needed for construction will not be allowed unless a comparison between the cost of excess acquisition and needed acquisition, including damages, indicates that benefits from such a transaction would result. Title to residual property will be vested in the name of the CITY. Revenues derived from the sale of these properties, less the cost of the sale of these properties, will be forwarded to the DISTRICT.
- 8. Administrative settlements and acceptance of counter offers involving right-of-way may only be made following a review and approval by the DISTRICT.
- 9. The DISTRICT will pay the CITY, or make payment directly to its contractor or its consultant, each month for project costs as outlined in SECTION II PROJECT COSTS.
 Invoices must identify and allocate all costs to the categories noted below:
