1. Call to Order

The meeting was called to order by Steve Parrish (CCRFCD). A quorum was present.

2. Comments By the General Public

3. Action to appoint a Chair and Vice-Chair of the SQMC (For possible action)

Steve Parrish (CCRFCDD) was nominated as Chair of the SQMC and Lance Olson (COH) was nominated as Vice Chair. Both nominations were approved.

4. Action to approve the agenda (For possible action)

The proposed agenda was approved.

5. Action to approve the minutes from the May 14, 2024 meeting (For possible action)

The meeting minutes from the May 14, 2024 SQMC meeting were approved.

6. Receive an update on the implementation of the new MS4 permit and the draft revised Stormwater Management Plan (For possible action)

John Tennert (CCRFCDD) provided an update on the implementation of the new MS4 Permit. The draft Stormwater Management Plan (SWMP) is due 1 year from issue date of the Permit (February 5, 2025). The final SWMP is due 6 months after receiving comments from the Nevada Division of Environmental Protection (NDEP). Following NDEP review, the SWMP will be open to public comment for 30 days. Comments will be addressed during a public hearing and the revised SWMP will be submitted to NDEP for review within 18 months of the issue of the Permit (August 5, 2025). The Permit requires that the new SWMP is streamlined to include numeric or narrative measurable goals for tracking implementation of Best Management Practices (BMPs). The current SWMP is more than 1,100 pages long whereas the version initiated in September 2023 is expected to be shorter and focused on Permit compliance activities. The SWMP requires that the Permittees collect samples from up to 10 storm events per year. To be sampleable, the event must have a total rainfall depth of 0.16” at applicable rain gauges in the watershed. The sampling is performed in 2 locations: The Club at Sunrise and Rainbow Gardens. A pending evaluation of data collected since 2010 indicates that either the Permittee’s MS4 maintenance activities are effective, or that a buildup of pollutants is not occurring.

Steve Parrish shared that CCRFCD has reviewed the quarterly reports and noted that all Permittees appear to be on track to meet MS4 permit goals.

For dry weather monitoring, Xiaoping Zhou (SNWA) shared that the 2024 results for total suspended solids, turbidity, and phosphate are relatively low when compared with the 2023 results. During 2024, quarterly sampling was performed in January, April, and July. The final sampling is in October.

Angela MacKinnon (Brown and Caldwell) shared that only one sampling event occurred during the 2023-2024 permit year.
